Given the extended Applications and Offers Submission Deadline until 03 April 2019 which term covers the first quarter of 2019, please confirm that the Bidders will not be required to provide Consolidated financial statements for 2018, if such are not audited.	Your understanding is correct, there will be no requirement for providing audited financial statements, if these are not available. Pursuant to Schedule 3, Part 1, paragraph 4(a)(iii) for the part not covered by the audited financial statements up to the 7th day prior to the Bid Submission Deadline an affidavit by the CFO will be sufficient.
2.	Given the extended Applications and Offers Submission Deadline until 03 April 2019 and the requirement to provide Identification documents of the Bidders in accordance with section III item "a" of Form A: Application, please confirm that the Bidders are allowed to submit in the Procedure Identification documents under section III, item "a" of Form A: Application, issued in the period November - December 2018, provided that no changes have occurred in the current status of the Bidder.	Bidders are free to submit Forms and documents already prepared, where a specific date of a Form or document to be submitted with the Application and/or Offer is not expressly provided by the Tender Documents, bearing in mind the responsibility also under Bulgarian criminal laws of false and inaccurate information (where applicable). In this regard, please note that at least a declaration should be submitted, signed by the persons concerned, certifying clearly that there is no change in the relevant circumstances or, accordingly, in case such a change has occurred, new documents must be presented. Please bear in mind that the period from the end of January to April is not a short one and there might be changes in the declared or certified circumstances.

Given the extension of the Applications and Offers Submission Deadline until 03 April 2019, please confirm that documents [Forms] signed in the period December 2018 - January 2019 may be used by the Bidders in the Procedure, and also please confirm that, in case of lack of amendments in the form or contents of the respective Form of the Tender Documents, it will not be necessary for this Form to be re-signed on a date closer to 03 April 2019. Given the extended Applications and Offers Submission Deadline, please clarify which calendar date shall be specified as validity period of the Participation Guarantee which shall be issued according to Form D, schedule 3 of the Tender Documents.	The validity period of the Participation Guarantee shall be 27 April 2020.

Given the extended Applications and Offers Submission Deadline until 03 April 2019, please clarify whether further amendments to the Tender Documents and/or the Concession Agreement are expected, and if yes, when such amendments will be announced.	Changes to the Concession Agreement and Tender Documents will be published in due time.
