On approving Notice of Amendment of Notice № 2018/S 127-290417, published in the Official Journal of the European Union on 5 July 2018 and in the National Concessions Registry on 5 July 2018, as amended by a Notice of Amendment No. 2018/S 193-437611 dated 6 October 2018 and in the National Concessions Registry on 6 October 2018, Notice of Amendment No. 2018/S 216-495082 dated 9 November 2018 and in the National Concessions Registry on 9 November 2018, Notice of Amendment No. 2018/S 248574899 dated 26 December 2018 and in the National Concessions Registry on 26 December 2018 and Notice of Amendment No. № 2019/S026-058902 dated 6 February 2019, published in the Official Journal of the European Union on 6 February 2019.

Pursuant to Art. 77, paragraph 1 and 2, and Art. 79, paragraph 4 of the Concessions Act, and considering that pursuant to Art. 10, paragraph 1, Art. 17, paragraph 2, Art. 39, paragraph 1, Art. 53, paragraph 1, Art. 71, paragraph 1 and Art. 72, paragraph 1 and paragraph 2.1 of the Concessions Act, Art. 43b, paragraph 1 and 3 of the Civil Aviation Act, with Decision № PK-1/02.07.2018 of the Minister of Transport, Information Technologies and Communications was opened a procedure for selection of concessionaire and award works concession for “Civil Airport for Public Use Sofia” – public state property, and proposal by the Commission on the conduct of the Tender Procedure:

I INSTRUCT:

I. I hereby approve the Notice of Amendment of Notice № 2018/S 127-290417, published in the Official Journal of the European Union on 5 July 2018, and in the National Concessions Registry on 5 July 2018, as amended by a Notice of Amendment No. 2018/S 193-437611 dated 6 October 2018, Notice of Amendment No. 2018/S 216-495082 dated 9 November 2018, Notice of Amendment No. 2018/S 248-574899 dated 26 December 2018 and Notice of Amendment No. № 2019/S026-058902 dated 6 February 2019, in accordance with Appendix 1.
